6.2 PNLS Headquarters Staff (Bi-)Monthly Payroll Advance Motion We have changed the frequency for the staff payroll from getting paid at the end of the month to having an optional advance at the middle of the month and the remaining balance at the end. We checked out the possibility of changing the listed payroll frequency to bi-weekly, but there would be a significant amount of necessary process work through CRA, and it was determined instead that those who want an advance can get it with minimal disruption to the existing payroll timing structure that we have always had.

In our Employment Terms policy, we have a section already for providing an advance, but it was previously only available by request once per fiscal year. We can instead change the wording to reflect that an advance is available each month for those who wish to participate.

- 7.3 Fundraising Activities and Targets
  The Northern Reading Program has finished, and the Summer
  Reading Program is being worked on.
- 7.4 KidsFirst NORTH & Northern Family Literacy Hubs Update
  Kids First NORTH Family Literacy Hubs now have access to the
  Teacher Cards; theirs will likely be renamed to Educator Cards to
  limit potential confusion. We have some ideas for purchases.
  Learning outcomes for students are sliding back because of the
  pandemic disruptions and we are hoping that providing these
  learning materials can help lessen those impacts.
- 7.5 SUMA Convention 2022, April 3 6 James will be attending the SUMA convention in Regina. This convention gives us some face time with local and regional representatives, and he will be able to check out potential new promotional items for the library ststen.
- 7.6 2022 SLA Conference, May 4 6, Regina The SLA conference will be held in person in Regina, and the early bird deadline is March 14, 2022. Hotel rooms are available at the Hotel Saskatchewan under special preferred rates. He will send out the registration to the libraries and see if there are others who will want to attend. James has been recruited as the Master of Ceremonies for the Conference.

#### 8. Programs

- 8.1 SaskPower Northern Reading Program 2022
  The Northern Reading is now completed for the year and the Reading Challenge Winner is La Loche. There will be a presentation of the trophy on March 26, 2022. We will get a new plaque to put on the trophy. The Writing Challenge and Poster Challenge winners will receive books.

  The Aboriginal Storytelling Month is now completed. The launch went well. There was an NRP writeup in the Northern Advocate. Due to the pandemic, there was no tour this year.
- 8.2 Summer Literacy Camps and/or TD Summer Reading Club 2022 The theme is "Once Upon a Time". There will be supports for the story walk and promotional materials ordered. Assuming the summer literacy camps move forward this year, the planning for the camps will be done through Frontier College and Northern Lights School Division 113, and the Literacy Camp Coordinators will meet for training in Prince Albert.

9.1 Member Library Workbee Requests
Green Lake- Because they are on Follett Destiny, we can have the books shipped here, processed, and shipped back.
Bell's Point- Gerald Ross is the new librarian there. He went through the library tech training on the PNLS bursary. He is looking for weeding and recommendations for the library.
Sucker River- Mark Williment is the new principal there. They will need weeding.
Beauval- They need weeding done.
